



Privacy Policy

This Privacy Policy defines major privacy principles that we apply to the information we collect. The purpose of the Privacy Policy is to inform the users about the types of data collected, the ways how it is collected and processed, the purposes of its usage and sharing, as well as the ways the users can maintain their confidentiality or privacy.

Please read this Policy carefully. Clauses applicable only to US or EU residents will appear below separately.

Information We Collect

Anonymous User Information (Data)

Non-personal information is any information that does not personally identify the user (for example, information about the jurisdiction the user is from). We obtain non-personal information about you from information that you provide to us. This information may be collected when publishers, advertisers, ad networks and agencies (collectively: **"Advertisers and Publishers"**) use our services or systems.

Additionally, certain other information (such as cookies, which are described below) may be transmitted by our server to your computer. That information does not contain any personally identifiable information. Specific types of anonymous information are described below.

User Information

Identifiable information means any information that can identify you as an individual, when you voluntarily provide this information, such as when you submit this information to the Website. The personally identifiable information we collect includes, but is not limited to, your first and last name, home address, telephone number, email address, date of birth, gender, income, and driver's license information. We may also collect information about your driving history, the type of automobile you drive, your home ownership history, and certain health information such as whether you have been treated by a doctor for a major health condition.

We may use your personally identifiable information for any lawful purpose, including to deliver our products and services to you; to display customized content and advertising; to conduct research and analysis; to ensure that the Website is functioning properly; to aid us in developing new services; to alert you to product updates, special offers, updated information, and other new services; to contact you in response to your requests for information; to send newsletters and other information to you; to provide you quotes from Service Providers who may contact you using the information you provide; and to obtain additional information needed from you.

As part of our ad delivery and reporting, we log page views and bid requests and collect information for the purpose of delivering ads or providing advertising-related services, including providing a specific advertisement based on a particular type of browser or time of day; statistical reporting in connection with the activity on a Web site; and tracking the number of ads served on a particular day to a particular Web site (tracking web analytics data). To do so, we collect information about the type of browser, referrer and operating system of Web site visitors, as well as the domain name, day and time of visit, and page(s) visited. We do so across multiple Web domains owned or operated by different entities (each, a "Site").

Cookies and Log Files

We use Cookies to serve advertisements to users. Cookies are small text files placed on your hard drive that assist us in providing a more customized website experience. It is our policy to use cookies to make navigation of certain websites related to our Services easier for visitors.

In order to properly manage our website, we may anonymously log information on our systems, and identify categories of visitors by items such as domains and browser types. These statistics are used

to manage the operational efficiency of our systems.

If you are concerned about cookies, most browsers permit individuals to decline cookies. If you opt-out from accepting cookies you should know that Interest-based advertising gives advertisers the chance to show ads that are relevant to you based on your online web browsing behavior. With interest-based advertising, you receive ads and offers that are more likely to be useful to you. Advertisers may also use other information they have or acquire about users' interests. You can opt-out of interest-based advertising. If you choose to opt-out you will still see ads, but it is more likely those ads won't be relevant to you. Interest-based advertising does not depend on information that is personally identifiable to you, such as your name, address, phone number, etc.

When you opt-out, an opt-out cookie will be stored in your web browser. Our Platform will know the choice you have made when it sees your opt-out cookie, and will apply your choice to all ads served by the Platform. If you block or delete the opt-out cookie, the Platform will not see your choice. The opt out cookie may not work if your browser is configured to block third-party cookies. If you delete your cookies, you will need to opt out again. There are browser plugins to help you preserve your opt out cookies. The opt out only applies to the browser in which you set it. For example, if you set the opt out while using Firefox, but then use Chrome, the opt out will not be active in Chrome. To opt out in Chrome, you will need to repeat the opt out process. The opt out does not block or delete cookies, or prevent the use of cookies or other technologies for purposes other than selecting ads based on your interests as inferred by your online behavior. If you opt out, data may still be collected about your web browsing activities and you will still see advertising. Ads may be selected, for example, based on the content of the web page in which they are shown. If you wish to block or delete cookies altogether, you can use web browser settings to do so.

How We Use Information Collected

We may use personally identifiable data you provided in order to provide you with our services or to serve you with advertainments and offers logically associated with the purpose you provided such details, by text messages, Email, phone calls, autodialed phone calls etc, pursuant to your choices according to the FCC's 1-to-1 Consent Rule. for this purpose, we may share or use your information with relevant entities making the advertainments and offers to you or in order to:

- Share it with our Corporate Affiliates.
- Share it with our Vendors and Suppliers. We may share the information we collect on the Website with our vendors and service providers for the purpose of verifying data and where such access is incidental to their providing us services, such as phone number verification services and email service providers.
- Protect our rights and the rights of others when applicable.
- Disclose the information when required under any law or according to an applicable authority order or request.
- To provide you with the opportunity to participate in sweepstakes, contests, giveaways, or other promotions and programs offered by us, either alone or with third parties. Participation in these promotions or programs may require you to submit additional personally identifiable information. Our use and sharing of your information, including personally identifiable information, collected through a promotion or program will be governed by the official rules or agreement governing that promotion or program, as well as by this Privacy Policy. The terms of those rules or that agreement will supersede any conflicting provisions of this Privacy Policy.

We use non-personally identifiable data collected from users and website visitors in order to: (a) To improve the quality and functionality of the website, enhance your experience, create new services (including customized services), change/cancel existing content and services, or for other internal and statistical purposes; (b) To present you relevant content, marketing materials and advertisements, by analyzing your interests from the web pages you visit and online services that you use; (c) To provide you with support and handle inquires; (d) To enforce our terms of use; (e) To comply with any applicable law and assist law enforcement agencies as required; (f) To conduct surveys and market research; (g) To improve the quality and functionality of the website, enhance your experience, create new services (including customized services), change/cancel existing content and services, or for other internal and statistical purposes; (h) To present you relevant content, marketing materials and advertisements, by analyzing your interests from the web pages you visit and online services that you use.

We may combine Non-Personal Information with data collected from other sources and disclose the Non-Personal Information and combined information to participating Advertisers and Publishers so that they can determine whether provide you with advertisements and offers or in order to improve the relevance of the advertising presented to Users. Examples of such data include: (a) country, city, and other geo-location details based upon the IP address of the User; (b) other data from advertisers and data providers that would help in ad targeting (e.g., an advertiser that wants to advertise to Users who have previously visited the advertiser's website).

How we protect the Collected Information.

Information that we collect is stored on servers, using standard security procedures and practices appropriate to the nature of the information in an effort to protect information from unauthorized access, destruction, use, modification, or disclosure. If we learn that we have unexpectedly stored personal information (e.g., if we become aware that a URL that we store contains personal information), we will use commercially reasonable efforts to anonymize or purge this information.

Giving and Revoking Consent to Text Message and Telephone Marketing

By submitting your telephone number on the Website, you expressly authorize us our applicable Advertisers and Publishers and their agents and partner companies to contact you, at the telephone number you provide, with informational and marketing messages and telephone calls including those sent via automated telephone dialing system, text messages, SMS, MMS, picture messages, live and prerecorded telephone calls, including on landlines and wireless numbers, even if the phone number you provide is on a corporate, state, or national Do Not Call list. Your consent to receive text or telemarketing offers is not required to purchase goods or services. Message and data rates may apply. You may revoke your consent at any time by contacting us at the contact details below.

Do Not Track Disclosures

Third parties such as advertising networks, analytics providers, and widget providers may collect information about your online activities over time and across different websites when you access or use our Service. Currently, various browsers offer a "Do Not Track" option, but there is no standard for how Do Not Track should work on commercial websites. Due to the lack of such standards, the Site does not respond to Do Not Track consumer browser settings.

Third Party Sites

Please be aware that other websites and services, including the websites of third parties that you connect with through our Website or Service, may collect personally identifiable information about you. You should be aware that such third-party applications may share user information. We may use third-party services such as Google Analytics to help us understand how users use the Website or Service and to improve the ways in which we interact with users, including the refinement of interest-based ads displayed to users. Such services, including Google Analytics, may collect information about your use of the Website or Service through cookies, advertising identifiers, and other technologies. The collection and use of data by such third parties, including Google Analytics, are subject to their privacy policies.

Provisions for European Economic Area Residents

If you are a European resident, you have the right to access personal information we hold about you and to ask that your personal information be corrected, updated, or deleted. If you would like to exercise this right, please contact us through the contact information below.

Additionally, if you are a European resident, we note that we are processing your information in order to fulfill contracts we might have with you (for example if you register with the Site), or otherwise to pursue our legitimate business interests listed above. Additionally, please note that your information will be transferred outside of Europe, including to United States and other countries.

Provisions for United States Residents

This section contains disclosures required by the California Consumer Privacy Act ("CCPA") and applies only to "personal information" that is subject to the CCPA.

Other states, and especially Colorado, Connecticut, Utah and Virginia, have enacted comprehensive consumer data privacy laws. The laws have several provisions in common, such as the right to access and delete personal information and to opt-out of the sale of personal information, among others.
